Automatically stored non-personal data

When you visit our website, we store certain information for administrative and technical

reasons. This includes: Type and version of the browser used, date and time of access, and

Cookies

and stored on its hard disk. The legal basis for the use of cookies is Art. 6 sect. 1 lit. f DSGVO

(GDPR).

Only the Internet Protocol address is stored in this context, but no other personal data. This

information which is stored in the cookies allows us to automatically recognize you the next

time you visit our website, which will facilitate your using it.

Of course, you can also visit our website without accepting cookies. If you do not want your

computer to be recognized the next time you visit, you may also decline the use of cookies

by changing the settings in your browser to "Refuse cookies". The respective procedure can

be found in the operating instructions of your respective browser. If you refuse the use of

cookies, however, this may lead to restrictions in the use of some areas of our websites.

Google-Analytics with anonymisation function

On our website, we use Google Analytics, a web analytics service provided by Google Inc.,

1600 Amphitheatre Parkway, Mountain View, CA 94043 USA, hereinafter referred to as

"Google". Google Analytics uses "cookies", which are text files placed on your computer, to

If you have consented to Google linking your web and app browser history to your Google
